WHAT IS THIS PRODUCT?**TYPE**

The term of this product is unlimited.

OBJECTIVES

The Sub-Fund aims to beat the stock market over the long term, and to outperform the Stoxx Europe 600 Index Net Return over an investment horizon of at least five years. At least 75% of the total exposure of the Sub-fund will be invested in equities and the remaining total exposure will be in debt securities. The foreign exchange risk will reach a maximum of 100% of the Sub-Fund's assets. The Sub-Fund is actively managed and the composition of the portfolio may differ at times from the composition of the Stoxx Europe 600 Index Net Return.

INTENDED RETAIL INVESTOR

This product is intended for investors who plan to stay invested for at least 5 years and who understand the risk of the sub-fund and seek a return over the long term investing in equity markets.

WHAT ARE THE RISKS AND WHAT COULD I GET IN RETURN?

RISK INDICATOR

COSTS OVER TIME
